- I.  - III. The Joint Administrators will process personal data for the purpose of children's participation in the activities of UNICEF- "an activity implemented through a partnership between UNICEF and the Municipality of Sopot in the provision of emergency response support to refugees in the area related to the Ukrainian crisis" (refugee children and children in the area of protection, health, education, social care, youth development, etc.) in Sopot funded by "UNICEF - United Nations Children's Fund";
 - IV. The legal basis for data processing is Article 6(1)(e) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons regarding the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (hereinafter: RODO) in connection with the applicable legal provisions, including the Act of 12 March 2022. on assistance to citizens of Ukraine in connection with the armed conflict on its territory and the Act of 8 March 1990 on municipal self-government and the Act of 5 June 1998 on county self-government. We will process the personal data of image support recipients on the basis of their separately expressed consent in connection with Article 6(1)(a) of the RODO;
 - V. The recipients of your personal data will be: representatives of "UNICEF - United Nations Children's Fund", authorised employees of the Co-administrators, entities authorised by law, entities providing service and technical assistance to the Co-administrators' IT systems and domain programs, companies providing service maintenance of the Co-administrators' official websites, providers of social networks used by the Co-administrators, and the postal operator with whom the contract for the provision of postal and courier services by the Co-administrators has been concluded;
 - VI. Your personal data may be transferred to third countries or international organisations outside the European Economic Area. We may transfer your personal data to UNICEF in other countries when they provide adequate safeguards and provided that effective legal protections for personal data are in place - in accordance with Chapter V of the DPA;
Due to the possibility of publishing your personal data and image on the official social media accounts of the Joint Administrators, such as Facebook, YouTube, Instagram, your data may be transferred to the United States of America, where different data protection laws apply, which may not provide a sufficient level of protection.  - VII. There will be no automated decision-making or profiling based on the personal data received.
 - VIII. We will retain your personal data for the period necessary to fulfil the purpose for which they were collected, as well as for archival purposes, where required by the provisions of the Regulation of the Prime Minister of 18 January 2011 on the Registry Instruction, Uniform Material File Lists and the Instruction on the Organization and Scope of Operation of Company Archives i.e. for a period of 5 years;
 - IX. In accordance with the "RODO", you have the right to access your data and to receive a copy of your data, the right to rectify (amend) your data if they are incorrect or outdated, also the right to erasure where the processing of your data does not take place in order to comply with a legal obligation or in the exercise of public authority, and the right to restrict the processing of your data or to object to the processing of your data;
 - X. The person whose data is processed based on consent has the right to withdraw consent to the processing of his/her personal data at any time, to the extent that he/she has given such consent. The withdrawal of

consent will not affect the compatibility of the processing with the applicable law that was carried out based on consent before its withdrawal.

- XI. The Joint Administrators also inform you that, pursuant to Article 77 of the "RODO", you have the right to lodge a complaint with the President of the Office for Personal Data Protection, 00-193 Warsaw, Stawki 2 Street, if you consider that the processing of your personal data violates the provisions of the General Data Protection Regulation (RODO);
- XII. The provision of personal data is voluntary, however, without providing such data it will not be possible to obtain the support
